- **062472 6.** Jennifer Snead reported a total of 3 applications were received. At the April  $20^{\text{th}}$  Blue Ribbon Advisory Task Committee (BRATC) meeting, each applicant was given 10 minutes to present their project followed by a question and answer period by the committee members. All projects met the BRATC quiding principles.

Upon conclusion of the scoring process, Uniontown Community Development Association placed first, the City of Pullman placed second, and the Port of Whitman County placed third.

Commissioner Partch received a call from John Sherman at the City of Pullman requesting their application be withdrawn. The City's reasoning was based on the award amount and a new BRATC policy whereby the City could not apply with a similar application for 5 years. The City will make application next year allowing them time to be more prepared. This item is scheduled for the Council's April 27<sup>th</sup> agenda.

Motion by Commissioner Partch seconded by Commissioner Finch to approve the #1 and #3 projects and to hold off on #2 until the county hears from the Pullman City Council after their April 27<sup>th</sup> meeting. The commissioners thanked the applicants, the committee and Jennifer Snead for their work associated with this years' allocation. Commissioner Finch felt they are all good projects that will make things happen in Whitman County. Commissioner Partch commented Uniontown's project ties in with the Scenic Byways and the Port's application will help the Business Air Center in Colfax. Chairman Wigen said Uniontown's project is unique in that it promotes the culture and heritage of Whitman County. Motion carried.

D062485A THE BOARD OF WHITMAN COUNTY COMMISSIONERS met in their Chambers in the Whitman County Courthouse, Colfax, Washington for April 27, 2004 at 2:00 p.m. Les Wigen, Chairman and G.R. "Jerry" Finch, commissioners and Maribeth Becker, CMC, Clerk of the Board attended. Commissioner Partch is attending a Council on Aging and Human Services meeting.

#### 2:00 a.m. - Reconvene/Board of Health.

Present: Fran Martin.

- **D062485B 1.** As part of the ABCD program, the SmileMobile screened 56 children; 34 had restorative treatment and the remaining 22 had varnish treatments.
- D062485C 2. Through the ABCD program, an educational program will be held on April 29th at the Quality Inn. The instructor is a dentist from the University of Washington Dental School who will teach medical personnel how to identify oral health diseases in children. The physicians will obtain credit for attending the training.
- **D062485D 3.** The ABCD Partnership program is well established in Columbia, Garfield, and Whitman Counties. Asotin County did not respond to the inquiry for involvement in the  $2^{\rm nd}$  year portion of the grant, and have therefore been eliminated from the 2004 grant process.
- **D062485E 4.** Asotin County was also dropped from the 4-county Tobacco Partnership. There were recently 19 compliance checks. One problem was discovery and immediately corrected.
- **D062485F** 5. The WIC program has offered Whitman County funds for improving the waiting room area in Colfax. This years WIC focus is on immunizations and referred to as the "WIC Roundup".
- D062485G 6. Contracted schools for public health nurses are all on target. The 2003 year end report has been completed for Whitman and Columbia Counties. The figures revealed, of the \$1.8 million total, Whitman County contributed \$240,000 from the general fund or 19% of the total Public Health budget.

**D062485H** 7. The Health Department is preparing a cost allocation plan to see if the results are better than what the county came up with for allocating costs.

D062485I 8. An emergency management crisis workshop was conducted last week. Booklets were prepared on how to respond to the public without startling people. A list of the most frequently asked questions by reporters during a crisis was distributed to the commissioners.

**D062485J 9.** Ms. Martin expressed her concern about the outrageous amount of sexually explicit information (spam) coming into the county's email system. The commissioners will visit with the Information Services Director regarding this matter.

**D062485K** 10. The Director reviewed the 3 statements of qualifications received for preparing the Whitman County All Hazardous Mitigation Plan as follows: Gray & Osborne, Yakima, WA, Munir Daud, Pullman, WA, and Tetra Tech, Eagle, ID.

Upon completion of a review and ranking by the County Engineer, an Environmental Health Officer, the Sheriff, and Undersheriff, an interview could be conducted with the vendor who ranks #1 or the county could simply choose to enter into a contract with the #1 vendor.

It was agreed Ms. Martin will return to the Board next week with the results of the ranking.
