This contract provides for the improvements of Wawawai Road, County Road No. 9000 and Wawawai-Pullman Road, County Road No. 9010 by removing guardrail, installing guardrail, traffic control and other work, all in accordance with the Contract Plans and Provisions and the Standard Specifications. The Engineer's Estimate is \$350,000 to \$425,000.
