**NOTICE OF MITIGATED- DETERMINATION OF NON-SIGNIFICANCE (M-DNS) AND  
A CONDITIONAL USE PUBLIC HEARING CONDUCTED BY ZOOM**

Whitman County Planning issued a Mitigated-Determination of Non-significance (M-DNS) under the State Environmental Policy Act Rules (Chapter 197-11 WAC) for the following project:

Northwest Grain Growers proposes to operate a commercial agricultural commodity warehouse on an approximate 20-acre parcel in the Agricultural District, located approximately 0.5 miles north west of Endicott, on the Endicott Road in Section 30, Township 17N., Range 41E., W. M., Whitman County, Washington.

After review of a completed environmental checklist and other information on file with us, the Planning Office has determined that this proposal will not have a probable significant adverse impact on the environment.

The public is also notified of a conditional use hearing request in front of the Board of Adjustment on May 13, 2021 at 7 PM
