Permits that are being issued are mainly for mornings, when the ground is still frozen, and for feed and fuel only. A warming trend is expected which will cause permitting to be more restrictive.

Mark Storey said he has documents ready to share with Kelli Campbell and Commissioner Swannack regarding the ADA Transition plan. They will be part of the hiring process of a consultant.
